

# MI'KMAQ NATION POSITION DESCRIPTION



### TITLE: Community Intervention Specialist

### **IMMEDIATE SUPERVISOR:** Unit Director/ Intervention and Recovery Program Director

## CLASSIFICATION: Full-Time (Contingent on Grant) 2 positions

This person will be responsible for supporting individuals and families struggling with difficult behaviors surrounding mental health and substance use, in need of support due to trauma, or other debilitating issues. He/she will work in group environments as well as individuals in order to support consistency between Circle of Care of Team and home. This service will be designed to encourage connection, communication, and health. He/She will be expected to participate in community events when needed, and demonstrate the ability to represent Mi'kmaq Nation and Boys and Girls Club within the community in a professional and positive way.

Qualifications: Applicant must have experience in intervention procedures and recovery practices or an Associate in a related degree field such as mental health or substance use. A valid driver's license is necessary for this position. Ability to demonstrate a high level of communication skills in diverse environments.

**Responsibilities:** 

- Create fun and engaging ideas to encourage individuals and family to participate in program
- Work in conjunction with Micmac Family Health, Indian Child Welfare Act Coordinator, Micmac Advocacy Center and other health providers.
- Coordinate with Micmac Family Health, Indian Child Welfare Act Coordinator, and other mental health providers to establish relationships with individuals and families to meet their needs in a timely manner
- Utilize support plans and safety plans in order to educate participants in replacing unhealthy/unsafe behaviors to create a healthy home environment.
- Complete data collection and other documentation and process it according to protocol on a daily basis.
- Attend outreach functions to build relationships with the community, families and youth.
- Any other tasks deemed necessary to better the quality of BGC of PI program or safety, health and welfare of the families and youth attending.





End Results:

- A positive role model for staff, families, and youth at all times
- Ensure the safety, health and welfare of our families and youth
